

Camper Driver Permission, Agreement and Waiver Form

Camp Oak Hill Parent/Guardian Agreement and Liability Waiver

I, the undersigned parent(s)/guardian(s), permit my child ("the Camper"), _____, to drive to and from Camp Oak Hill ("Camp"/"COH") for check in and check out days. In granting my permission, I agree to the following:

- As stated in the Camp's registration policies, summer camp participants are classified as "minors" for COH purposes even if they are over 18 years of age. I am responsible for the Camper as parent/guardian.
- The Camper has a current/valid state driver's license; the vehicle's registration, insurance and inspection are up to date, and the Camper is insured on the vehicle.
- The parent(s)/guardian(s) and/or the Camper and/or the driver assume the risk of harm, injury of death to the Camper or others, and that by voluntarily allowing the Camper to operate his/her own vehicle, the parent(s)/guardian(s) and the Camper will hold Camp Oak Hill and its officers and employees free from all liability.
- I agree that I am responsible for deciding when it is safe/unsafe to allow the Camper to drive to/from COH (e.g. poor weather, sickness, fatigue).
- I understand that the Camper agrees to drive safely and in accordance with all laws and regulations.
- I give consent to have the Camper sign themselves in and out of camp during the check in and out process, handle their own medications, and financial need of the camp store.
- I understand that the Camper must arrive to Camp in the agreed upon check in times, must not leave Camp early with the consent from a parent/guardian, unless COH has written consent for the Camper to leave earlier than scheduled check out, and must not in any way abuse the privilege of driving to/from COH.
- I agree that the Camper is prohibited from driving other campers to and from COH without the express, written consent and release of liability from all parents/guardians involved, including myself.
- I understand that the Camper's car is effectively "off limits" (no loitering in/around car) during any time during the session.
- I agree that the Camper has read and agrees to these provisions as well as the rules in the Camper Code of Conduct.
- I agree that Camp Oak Hill at its sole discretion may revoke the Campers's privilege to drive to and from COH for any reason.
